

**Please Note:** Fees are based on the number of masses or lesions biopsied. Therefore, each separate site will count as one (1) biopsy. **Standard biopsy charge (HB002, HB011, and HB013) for the first mass depending on size. Additional charges will apply per additional mass based on size (HB114, HB115, HB116).** If more than one mass is submitted, the one with the largest linear dimension will be considered for the initial standard biopsy charge. In rare circumstances, preparation of additional slides may be required for a thorough evaluation of a particular biopsy specimen; **additional slides beyond standard will be charged separately (HB007).**

Sometimes pathologists will request extra special staining procedures at their discretion to attempt a definitive diagnosis on biopsies. There will be additional charges for these stains, and they will be billed to the client. If a pathologist recommends immunohistochemistry (IHC) or any other testing on a biopsy, the pathologist will indicate his/her recommendation within the comment section of the report. If the client agrees and approves additional testing, the client will need to contact the laboratory and indicate the desire to proceed with the additional testing. Additional charges for IHC or other testing will be billed to the client after obtaining consent.
